- To the fullest extent permitted by law, the Undersigned (and on behalf of the Undersigned's personal representatives, heirs, next 2. of kin, and assigns) RELEASES, WAIVES AND DISCHARGES, AND COVENANTS NOT TO SUE, the owner of the Property, Hunt Real Estate or Maya Haddad (the owner's real estate agent(s)/Broker, the owner's attorneys or any person engaged by any of them to perform any work or services at the Property, and their officers, directors, stockholders, members, employees, representatives, agents, employees, parents, subsidiaries, sureties, insurance companies, affiliates, partners, joint ventures, attorneys, predecessors, successors, and assigns (collectively, the "Releasees") from any and all damages, losses, penalties, liabilities, costs, attorney's fees and expenses of any nature, and any demands, claims, suits, and causes of action therefor, arising out of or resulting from the Undersigned's presence at the Property.

- The Undersigned acknowledges that he/she has sole responsibility to evaluate carefully the risks inherent in accessing the 5.
